The Event will be held under the FIA International Sporting Code including Appendices, the National Competition Rules (NCR) of Motorsport Australia. The Hillclimb Standing Regulations of the Motorsport Australia Manual, the Motorsport Australia Come & Try Policy, these Supplementary Regulations and any Further Regulations and Bulletins that may be issues.

The Event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1st, Integrity and Legal, and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au.

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. Further details can be found in the Motorsport Australia Insurance Handbook, available at www.motorsport.org.au.

1. EVENT STANDING

This event will be held on 29th March 2026 and is a **Club Hillclimb** and forms part of the Collingrove Challenge Trophy Series. The Event will be held at Collingrove Hillclimb, 71 Hillclimb Road, Mt McKenzie 5353 (8kms from Angaston on the Eden Valley Road).

The Hillclimb is a bitumen sealed surface course, approximately 1km long and 3.3 metres wide. Catering is available at the track.

A SPEED LIMIT OF 10 KM/H APPLIES ON THE RETURN ROAD AND IN THE PADDOCK AREA.

3. ENTRIES

Open with the Publication of these Supplementary Regulations and closed on **Sunday 22nd March 2026**.

Entries must be made using Motorsport Australia Event Entry System www.motorsport.org.au or on the attached Entry Form for up to 10 Come & Try participants. The form should be sent by email to motorsport@sportingcarclub.com.au or post to Sporting Car Club of South Australia, 51 King William Road, UNLEY SA 5061. Call the club on 8271 5689 to make a card payment or a direct deposit can be made directly to the SCCSA account : BSB 633000 Account : 138466693, please use your surname as the reference.

The ENTRY FEE (GST inclusive) is \$140.00 for Sporting Car Club Members and \$175.00 for non-Sporting Car Club members. Speed Junior Licence holders aged 14-17 will be eligible for a discounted entry fee of \$90.00.

LATE ENTRIES MAY BE ACCEPTED AT THE DISCRETION OF THE EVENT ORGANISERS AND A LATE PAYMENT FEE OF \$50.00 WILL APPLY.

All participants must hold a Motorsport Australia Licence Speed/Speed Junior licence or higher. An Introductory Licence (Come & Try Licence) may be used for Come & Try entrants, and a Single Event Licence is available for competitors. The terms and conditions of these licences are available at www.motorsport.org.au.

A valid Motorsport Australia Licence, and Road Registration Certificate or a Motorsport Australia Vehicle Logbook, **if issued** must be presented at document check.

The Entry Fee will not be refundable except:

- In case of abandonment of the Event
- Where the entry is withdrawn by written advice to the Secretary of the Event by the fifth day prior to the Event.
- Where an entry is refused.

Entries will be limited to 120 and shall be accepted in order of receipt when the short track is in use. Entries will be limited to 100 when the long track is in use. This Event will be held on the short track. Entries may be refused in accordance with the NCR.

The entry of multiple vehicles and multiple Drivers can be accepted at the sole discretion of the Organisers under the following conditions:

- An additional Entry must be raised for each entry combination
- A separate Entry Fee is payable for each entry.

4. RUNNING ORDER

The running order will follow as closely as possible the order listed in the Official Running Sheet. Categories will be grouped for each timed run as far as possible. In the case of multiple entered vehicles, the running order will be managed to ensure that each run or re-run for a particular vehicle is separated by a period of not less than five minutes, irrespective of which Driver is in the vehicle. The Organisers reserve the right to change the running order where deemed necessary.

5. ELIGIBILITY OF VEHICLES

All vehicles shall comply with Technical Appendix Schedule A and B of the Motorsport Australia Manual. The vehicle must be in good roadworthy condition and may be inspected by Motorsport Australia scrutineers on the day.

A Motorsport Australia Self Scrutiny Statement of Vehicle Compliance Form must be completed for all vehicles and provided to the Sporting Car Club prior to the close of entries.

- Open sports vehicles are allowed to run.
- Seat belts must be fitted and be in good condition in accordance with Schedule I of the Motorsport Australia Manual.
- If fitted with an opening front panel (eg – bonnet), two separate fastening systems must be utilised. (Standard road registered vehicles comply with this requirement).
- Vehicles must be adequately muffled to comply with noise restrictions.
- Vehicle numbers will be issued on the day. Driver's preferred numbers will be issued where possible.
- Numbers need to be affixed to the Driver's side of the vehicle.

6. SCRUTINY

A Motorsport Australia Self Scrutiny Statement of Vehicle Compliance Form must be completed for all vehicles and provided to the Sporting Car Club prior to the close of entries. This will be provided to the Scrutineer who may choose to inspect your vehicle.

Drivers' apparel, including helmet, is to be as per Schedule D of the Motorsport Australia Manual and must be presented to the Scrutineers for inspection on request.

Any vehicle which, after approval, is dismantled or modified in any way which may affect the safety of the vehicle or raise questions as to its eligibility, or is involved in an accident having similar results, must be submitted for Re-Scrutiny. Any vehicle leaving the paddock area may also be subject to Re-Scrutiny. Any vehicle or Driver may be prohibited from the Entry for safety reasons. No competitor will be permitted to compete with exposed limbs.

7. PENALTIES AND PROTESTS

Competitors are reminded of the penalties imposed by Motorsport Australia for breaches of the Rules as laid out in the Motorsport Australia Manual.

Protests must be lodged in accordance with the NCR.

8. DRIVERS BRIEFING

Each Driver must attend the Drivers Briefing. The time and location of this briefing shall be detailed in the Supplementary and/or Further Regulations for the meeting. Attendance is compulsory and where Drivers fail to **SIGN ON** and be present for the duration of the Drivers' Briefing, a penalty shall be applied by the Stewards as per the Motorsport Australia Manual and may be varied by the Stewards of the Event in exceptional circumstances.

Drivers Briefing will be held in front of the Scrutineering Shed. For times, please refer to item 22 – Timetable.

10. PASSENGER RIDES, PARADES, DEMONSTRATIONS< PROMOTIONS RIDES

This Event may include Passenger Rides in accordance with the Motorsport Australia Passenger Rider Policy.

This Event may include a Parade in accordance with the NCR.

This Event may include Demonstrations in accordance with the NCR.

Any Parade or Demonstration will be conducted at the discretion of the Clerk of Course.

Minimum Passenger age is 12 years of age as at last birthday.

11. CANCELLATION & POSTPONEMENT

The Organiser reserves the right to postpone or cancel the Event in accordance with the NCR or any portion thereof, at any time owing to inclement weather or any other unforeseen circumstance.

12. RESULTS AND AWARDS

Results and Awards will be determined by point scoring. Refer to the 2026 Collingrove Hillclimb Series Regulations on the

13. SMOKING AND INTEGRITY

Smoking(which includes e-cigarettes and :vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy, Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy, apply to any activity authorised by Motorsport Australia as published at www.motorsport.org.au.

Any participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area, is prohibited until all Competition is concluded each day.

14. DRIVER TRAINING – PASSENGERS AS INSTRUCTORS ONLY

This Event will allow Instructors in vehicles.

- A briefing must be attended by each Driver and Instructor (and guardians of each Passenger if Passenger is under 18 years of age) conducted by the Clerk of Course prior to commencing.
- Instructors must:
 - Be experienced and have the permission of the Clerk of Course.
 - Instructors will hold a Motorsport Australia Officials licence of Coach.
 - The suitability of the Passenger is at the discretion of the Clerk of Course.
 - Wear the same protective gear as a Driver in accordance with Schedule D of the Motorsport Australia Manual.
 - Be fitted and restrained as required for each Automobile with consideration of their physical attributes.
 - Complete a Passenger Ride Entry Form and disclaimer.
 - Drivers must fill out a Passenger Ride Entry Form to ride as a Passenger.
 - Vehicles and Apparel used must pass Scrutiny.
 - Vehicles shall only carry one Passenger at a time, unless otherwise approved by Motorsport Australia.

15. AMINALS

No animals, other than registered companion and guide (sight and hearing) dogs, be allowed within the hillclimb property at all times. Any exceptions can only be authorised by the Clerk of the Course.

16. ELIGIBLE CLASSES

The following table details the applicable classes which must be applied in their entirety and without modification.

If fewer than 3 Automobiles are entered in a class the Organiser may, at their discretion, amalgamate only the displacement classes within that category.

The Organiser may invite additional classes not listed below.
