1. Purpose

The Sporting Car Club of South Australia Incorporated ("the Club", "we", "our" or "us") uses cookies and similar technologies on its website to improve user experience, enhance website performance and better understand how visitors use our online services.

This Cookie Policy explains what cookies are, how we use them and the choices available to website users.

2. What Are Cookies?

Cookies are small text files that are placed on your computer, tablet or mobile device when you visit a website.

Cookies allow websites to remember information about your visit, including:

- your preferred settings;
- login status;
- pages viewed;
- browsing behaviour;
- device information.

Cookies do not normally identify you personally unless you voluntarily provide personal information elsewhere on the website.

3. Why We Use Cookies

The Club uses cookies to:

- improve website performance;
- enhance user experience;

- remember website preferences;
 - improve website security;
 - understand website traffic;
 - identify technical issues;
 - assist members using online services;
 - measure website effectiveness;
 - improve future website development.

4. Types of Cookies We Use

Essential Cookies

These cookies are necessary for the website to operate correctly.

They may be used for:

- page navigation;
- secure logins;
- online forms;
- shopping carts;
- payment processing;
- member portal access.

Without these cookies, parts of the website may not function correctly.

Performance Cookies

These cookies help us understand how visitors use the website.

They collect information such as:

- pages visited;
- time spent on pages;
- navigation paths;
- error messages;
- website performance.

This information is generally collected in an aggregated and anonymous form.

Functional Cookies

These cookies remember your preferences, such as:

- language settings;
- accessibility preferences;
- previously completed forms;
- login preferences;
- device settings.

Their purpose is to improve your browsing experience.

Analytics Cookies

The Club may use website analytics services to better understand how visitors use the website.

Analytics may collect information including:

- number of visitors;
- geographic region (general only);
- device type;
- operating system;
- browser type;
- referring websites;
- popular pages;
- visitor trends.

Analytics information is generally anonymised before reporting.

Third-Party Cookies

Some pages may include content provided by third parties.

Examples include:

- online payment providers;
- embedded videos;
- mapping services;
- social media content;
- event registration systems;
- membership management platforms.

These providers may place their own cookies.

The Club does not control these cookies, and users should refer to the relevant provider's own privacy or cookie policy.

5. Cookies Used by Our Website

Depending on the services available at any given time, cookies may be used for:

- member login;
- event registrations;
- online merchandise purchases;
- membership renewals;
- facility hire enquiries;
- newsletter subscriptions;
- contact forms;
- website analytics;
- security monitoring;
- spam prevention.

As the Club's website evolves, the cookies used may also change.

6. Marketing Cookies

The Sporting Car Club does **not** use cookies to sell your personal information.

If marketing or advertising cookies are introduced in the future, users will be provided with appropriate notice and, where required by law, the opportunity to manage their consent.

7. Managing Cookies

Most web browsers allow you to:

- view cookies;
- delete cookies;
- block cookies;
- receive notifications before cookies are installed.

Browser settings differ between devices and browsers.

Users should refer to their browser's help documentation for instructions.

Please note that disabling cookies may affect website functionality.

8. Consent

By continuing to use the Club website, you consent to the use of cookies in accordance with this Cookie Policy unless you have disabled cookies through your browser settings or declined optional cookies using any cookie preference tools made available on the website.

Where Australian privacy laws require consent for certain categories of cookies, the Club will seek that consent before those cookies are activated.

9. Security

Cookies used by the Club are not intended to:

- collect unnecessary personal information;
- install software;
- transmit viruses;
- access files stored on your device.

The Club takes reasonable steps to ensure cookies used on the website are secure and appropriate.

10. Third-Party Websites

The Club website may contain links to external websites.

Those websites have their own cookie and privacy policies.

The Club accepts no responsibility for the practices of third-party websites.

Users are encouraged to review the policies of any external websites they visit.

11. Changes to this Policy

The Club may update this Cookie Policy from time to time to reflect:

- changes to website technology;
- legislative requirements;
- website enhancements;
- new online services;
- cybersecurity improvements.
