Website Terms & Conditions

Welcome to the Sporting Car Club of South Australia Incorporated ("the Club", "we", "our" or "us") website.

By accessing or using this website, registering as a member, purchasing products, entering events or using any online services provided by the Club, you agree to these Terms & Conditions.

If you do not agree with these Terms & Conditions, you should not use this website.

These Terms should be read together with the Club Constitution, Privacy Policy, Refund Policy and any event-specific regulations.

1. About the Club

The Sporting Car Club of South Australia Incorporated is an incorporated association operating under the **Associations Incorporation Act 1985 (SA)**.

The Club exists to:

- promote motorsport;
- preserve and celebrate historic motoring;
- conduct competitions and events;
- manage Collingrove Hillclimb;
- provide member services;
- preserve motoring history;
- support the wider motoring community.

These purposes are established under the Club Constitution.

2. Acceptance of Terms

By using this website you agree to comply with:

- these Terms & Conditions;
- the Club Constitution;

- Club Policies;
- Motorsport Australia regulations where applicable;
- event regulations;
- applicable Australian laws.

Failure to comply may result in:

- suspension of website access;
 - cancellation of registrations;
 - refusal of event entry;
 - suspension or termination of membership where permitted under the Constitution.

3. Website Use

You agree to use the website only for lawful purposes.

You must not:

- misuse the website;

4. Membership

Membership applications submitted through the website are subject to approval in accordance with the Club Constitution.

Submission of an online application does not automatically create membership.

Membership rights commence in accordance with the Constitution once an application is accepted and relevant fees have been paid.

Membership categories, subscriptions and member rights are governed by the Constitution.

5. Member Accounts

Members may be provided with access to online services.

Members are responsible for:

- maintaining password security;
- keeping contact details current;
- ensuring information supplied is accurate;
- protecting login credentials.

Members must notify the Club immediately if they believe their account has been compromised.

6. Event Entries

The website allows entry into various Club events.

Submission of an event entry does not guarantee acceptance.

The Club may:

- refuse entries;
- limit competitor numbers;
- close entries early;
- amend event formats;
- combine classes;
- postpone or cancel events.

Additional event regulations may apply.

7. Motorsport Activities

Participation in motorsport carries inherent risks.

By entering an event, participants acknowledge they:

- understand the risks;
- comply with event regulations;
- meet licensing requirements;
- satisfy vehicle eligibility requirements;
- accept Motorsport Australia rules where applicable.

Separate event waivers may also apply.

8. Online Payments

Payments may include:

- memberships;
- renewals;

- merchandise;
- facility hire;
- donations.

Payments are processed using secure third-party payment providers.

The Club does not store complete credit card details.

Prices are displayed in Australian Dollars (AUD).

9. Pricing

The Club endeavours to ensure all pricing is accurate.

If an obvious pricing error occurs, the Club reserves the right to:

- correct the error;
 - cancel the transaction;
 - refund any payment received.

Merchandise availability is subject to stock levels.

You warrant you own the rights to material submitted.

16. Historical Information

The Club maintains extensive historical records.

While every effort is made to ensure accuracy, historical information may occasionally contain errors or omissions.

The Club welcomes corrections supported by appropriate evidence.

17. External Links

The website may link to third-party websites.

The Club:

- does not control those websites;
